Pre-requisites:

1. Must be 15 years of age by the last date of class.
2. Must successfully pass the American Red Cross Precourse.

ARC Precourse:

1. Swim 300 yds continuously (100 yds front crawl, 100 yds breaststroke, and 100 yds of either front crawl or breaststroke)
2. In 1 min, 40 sec:
Swim 20 yards, surface-dive to 9 feet to retrieve a 10 pound brick, and swim back 20 yards to the starting point, holding the brick at the surface of the water.
