SWIM LESSON POLICIES AND WAIVER

PLEASE READ CAREFULLY BEFORE SIGNING.

THIS IS A RELEASE OF LIABILITY AND WAIVER OF CERTAIN LEGAL RIGHTS.

I, the undersigned participant or parent/guardian agrees and understands that swimming is a HAZARDOUS activity and request voluntary participation for myself/ my minor(s) to participate in the Central-Clemson Recreation Center (CCRC) Swim program/events, which are hereinafter referred to as the “activities”.

I consent to my/my minor(s) participation in the activities and acknowledge that the minor(s) and I fully understand my/my minor(s) participation may involve risk of serious injury or death, including losses which may result not only from my/my minor(s) own actions, inactions or negligence, but also from the actions, inactions, or negligence of others, the condition of the facilities, equipment, or areas where the program/event or activity is being conducted, and/or the rules of play of this type of event or activity. I understand that if I have any risk concerns, I should discuss the risks associated with my participation with the activity coordinators/event staff before I sign this document and before any activities begin.

Release – Parents’/Guardians’ Rights:

In consideration of the right to use the CCRC and/or to participate in CCRC programs, I hereby release the CCRC, Town of Central, City of Clemson and its officers, agents, employees, and representatives from any and all liability for injuries or damages, present or future, resulting from my participation in any activity or use of any equipment. I/We understand and agree that this release and waiver includes any claims based on actions, omissions, or alleged negligence, gross or otherwise, of the City of Clemson, and/or their elected officials, employees, agents, representatives, volunteers, invitees, guests, participants, contractors, and referees/umpires.

I hereby indemnify and hold harmless the Released Parties, of and from, and do discharge and waive, any and all claims, demands, losses, damages, and liabilities that I may have or sustain with respect to any and all damage and/or injury, of any type, arising from Minor Participant(s) participation in the activities. I also agree that if any portion of this agreement is held to be invalid the balance, notwithstanding, shall continue in full force and effect.

I certify that I/my minor(s) am/is in good health and have no physical or other condition that would prevent participation in this activity.

I authorize any representative of the CCRC Swim program/events to have the participant/myself treated in any medical emergency during participation of said activities. Furthermore, I agree to use my/minor(s) personal medical insurance as a primary medical coverage payment if accident or injury occurs.

SWIM LESSON POLICIES AND WAIVER

GROUP SWIM LESSON POLICIES

1. Absolutely NO refunds will be given for any reason
2. CCRC reserves the right to cancel any swim lesson containing less than 3 individuals
3. CCRC does not provide make-up lessons missed for personal reasons.
4. In the case of inclement weather the following conditions will apply
 - If at least twenty minutes of in-water instruction is provided the remainder of the lesson will consist of dry land safety instruction and will count as a full lesson.
 - If less than twenty minutes of in-water instruction is provided there will be one make up lesson due to inclement weather.
 - Lessons cancelled by the facility will be credited back to the account for future use.
1. Lessons are non-transferable to other individuals.
2. Member rates only apply to children within your household AND on your membership.
3. Classes will not be extended for late arrivals.
4. The CCRC does not guarantee that the same instructor will be teaching each lesson.

The following guidelines have been put in place for the safety of your children and our lifeguards. We sincerely ask that you assist us in providing the best experience for your children by following these rules. These rules have been implemented to help your children maintain focus on their instructors and improve their ability to swim. These lessons are meant to be fun for children and to ensure that they are fun and most importantly educational; we ask everyone to adhere to these guidelines.

1. Please arrive 10 minutes prior to swim lesson, dressed in appropriate swimwear.
2. Please take care of any bathroom breaks before the lesson so as to not disturb the lessons.
3. Instructors will meet your children on the bench in the pool area at the far end of the lap pool closest to the entrance.
4. Parents may sit on the bench at the far end of the lap pool and watch their children if they choose, or in the facility lobby area. Parents are not allowed to sit in any other pool areas.
5. In the event of inclement weather the Central-Clemson Recreation Center will provide 1 make up lesson, due to closure of the pool for lightning and/or thunder.
6. Parents must remain on the premises during the lesson.
7. A child in swim lessons does not grant you access to the facility, or the ability to swim prior to or after your designated swim lesson time. But, memberships are available. Memberships will also give you a discount on swim lessons.
