

Dear Friends and Members,

As we draw closer to reopening our pools we are also preparing to put into effect the policy changes previously mentioned.

There were of course several required changes to pool policies and accessibility brought on by our pool designation change. Additionally, we used this as an opportunity to review and update our facility policies and terms of membership so that they are as relevant and effective for our facility as possible. There are MANY VERY IMPORTANT updates that will be taking effect as of January 22, 2024 so we urge everyone to read over these carefully. Below you will find a highlight of some of the MOST important updates. Please take the time to review these as they may affect your next visit to the Central-Clemson Recreation Center. This is especially true if you have a child under the age of 18 years old who uses the facility!

KEY FACILITY POLICIES AND TERMS OF MEMBERSHIP CHANGES

FACILITY ACCESS

1. Anyone entering the facility must have a profile in our system, with the exception of specified rental guests and youth sports. For those under 18 years of age, the profile must be created by their parent or legal guardian.
2. Each person entering the facility must scan in immediately upon entering, and again each time they enter.
3. ALL members will be required to sign a new waiver to ensure they understand and comply with the new policies and regulations. You may be asked to do this at check in as well as be sent an electronic request.
4. Only yearly bank drafts or paid-in-full memberships receive guest Passes (12 per membership/per year). In order to use a guest pass the main account holder must accompany the guest into the facility and check them in or give prior consent for other account members to utilize guest passes.

MEMBERSHIPS AND ALTERNATIVE PASSES

We will now offer a weekly membership as an option. These will offer the same access as any other CCRC membership. Weekly membership will not include guest passes. Weekly memberships are PER PERSON ONLY.

Weekly rates are as follows.

- 3 yrs - 5 yrs: \$15.00 per week (7 days)
- 6 yrs - 64 yrs: \$21.00 per week (7 days)
- 65 plus yrs: \$15.00 per week (7 days)

POOL POLICIES:

1. The pools are now member-only pools. Only those with a CCRC membership are allowed to swim or be in the pool area.
 - Memberships that have guest passes (yearly memberships) may use a guest pass to bring someone into the pool or purchase a day pass in order to bring someone into the pool.
 - Members must remain in the pool area with their guests at all times and are responsible for ensuring their guests follow all pool rules.
 - Some special exceptions to pool entry may apply.
2. The pool will only be accessible via a key fob. A photo I.D. must be left at the front desk in order to pick up a key fob. If the fob is not returned prior to leaving the facility, the member will be charged a fee.
3. Members in possession of a key fob are responsible for ensuring only they and their registered guests enter the pool using their assigned key fob.
4. The pool may or may not be staffed with a lifeguard at any point during the day.

WATER FITNESS CLASS AVAILABILITY:

1. Non-members may purchase a membership to attend the water fitness classes.
2. Non-members may purchase a weekly class pass at \$6.00, allowing them to attend the therapy pool senior water fitness classes for one week.
3. A member can bring a friend to the senior functional water fitness class and the friend can pay \$2 for the class.

AGE BASED POLICIES:

1. Those 3 years old and up must have a day pass to use the facility if they are not members or their parent/legal guardian is not a member.
2. Those 6 years old and up must be added to and paid for on memberships.
3. Anyone 12 years old to 17 years old may hold an individual membership. Their parent or legal guardian must be present to register them.
4. Those under 12 years old may not hold an individual membership. A parent or legal guardian must hold a joint membership with them as well as be the one to create the membership.
5. Those under 12 years of age must have a parent or legal guardian, 18 years of age or older, present in the facility at all times.
6. Those who are under 12 years of age will not have access to the weight room, even with a parent or guardian accompanying them.
7. Children 12 to 14 years of age can be in the facility unattended, but they must have a CCRC profile in our system, registered by their parent or legal guardian prior to visiting the facility on their own.
8. Those 12 to 14 years old may be in the weight room or participate in a fitness class, ONLY if they are accompanied by and under the direct supervision of their legal parent or guardian at all times. The accompanying adult agrees that the Assumption of Risk & Release of Liability applies to themselves and the minor.
9. Those under 15 years old must be accompanied by and under the direct supervision of their legal parent or guardian while in the pool area.
10. Those 15 years or older are allowed to use the entire facility, including the weight room, participating in fitness classes, and utilizing the pool, and do not need to have a parent/guardian present while attending.
11. Those 65 years and older are considered seniors and receive the senior day pass rates and senior discounts on yearly memberships. The services that senior discounts can be applied to are subject to change.

All new terms and policies will take effect as of Monday, January 22, 2024.

Keep in mind that it may take a few minutes longer to check in and you may be stopped to add a picture, update information, ensure you are checked in properly, or sign your new membership waiver. Please be sure you adjust your arrival time to account for this.

We also ask that you are patient with our staff during this process as it is an adjustment for us all. Feel free to reach out with any questions you may have.

Pool Reopening: We have made leaps and bounds with our pool resurfacing and are very close to reopening. As of now we have an anticipated reopening date of Monday, January 22nd. We will make an announcement when this date is 100% finalized so please be on the lookout for that.
